It has now been two months since many schools and businesses closed in our area. Below please find some important updates and information as of May 15.



## **New National Guidelines, Information, and Policies Updates:**

- Today, the Centers for Medicare & Medicaid Services released a new CMCS Informational Bulletin (CIB) to provide states guidance on how to temporarily modify provider payment issues. [Read the CIB here.](#)
- The CDC has updated its list of COVID-19 symptoms and its guidelines for when people should seek medical help. [Link to CDC page.](#)
- On Wednesday, CMS released a new “toolkit” on state actions to mitigate COVID-19 prevalence in nursing homes. [Read Toolkit Report.](#)
- CMS is announcing a call for nominations for the new contractor-led Coronavirus Commission on Safety and Quality in Nursing Homes to help inform immediate and future responses to the Coronavirus Disease 2019 (COVID-19) within these facilities. [Get more information here.](#)
- The Trump administration announced plans to improve the Strategic National Stockpile of drugs and medical supplies, creating a 90-day supply to establish a "buffer" until the United States can boost domestic manufacturing surge capacity.

## **Regional Information and Information for Hospitals:**

Developments from around the MD-DC-VA area.

- As of Thursday evening, the numbers in our area are as follows: we have now surpassed 70,000 total cases with nearly 3,200 deaths. Cases continue to surge in our area even though there are one- or two-day periods where the rates seem to be holding steady.
- Parts of Maryland and Virginia will begin to slowly re-open starting today (Friday). The District of Columbia, however, is sticking to its “stay at home” policy until early June.
